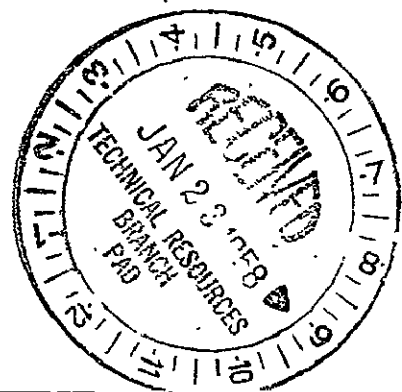
Attached are three copies each of publications prepared by the National Institute of Administration in conjunction with the Michigan State University Group Advisors.

The staff of the Library of the National Institute of Administration presents here its first complete printed catalog of the books in the library as of September 1957. This catalog is arranged by subject matter, classified according to the Dewey Decimal Classification, in order to facilitate the location of books on any one subject. An index to the Dewey Classification in both English and Vietnamese will be found at the end of the catalog.

It is hoped that this printed catalog will be of value not only to the faculty and students of the NIA but also to officials of the various departments and agencies of the Vietnamese government.

It is planned to keep this catalog up to date by the publication of monthly lists of new acquisitions and annual cumulative supplements.
