La bibliographie annuelle de l'AAQ est établie dans le cadre d'une veille continue effectuée par David Rajotte diffusée sur diverses plateformes. Elle recense des publications parues en français ou en anglais. La bibliographie tente de lister exhaustivement les titres publiés dans les principales revues archivistiques, qu'elles soient payantes ou en libre accès. Elle comprend également les monographies et les rapports mis en ligne qui sont susceptibles de faire avancer la profession. Certains périodiques de bibliothéconomie sont également dépouillés. Les articles traitant d'archives dans des périodiques d'autres disciplines sont également ajoutés. Les titres sont classés en 16 thèmes différents. Chaque titre ne fait l'objet que d'un seul classement. Le thème principal a été privilégié au détriment d'autres thèmes secondaires. La bibliographie est compilée et produite avec le logiciel Zotero.
