## Foreword

Québec legal literature is published either in French or in English or in both languages. This bibliography presents only English language or bilingual texts. It does not include the unilingual French publications which of course are the major part of Québec's legal literature.

This bibliography on Québec Civil Law and Procedure published in English has been prepared as a working tool in the context of the legal cooperation between the Faculty of Law of the University of Ottawa, the Saint-Lucia legal community and the University of the West Indies. It may also be a useful instrument for all other English speaking lawyers who wish to learn about Québec Civil Law and Procedure.

This compilation covers the period from the promulgation of the *Civil Code of Lower Canada* in 1866 to the end of 1984. It is partly based on Reynald Boulton's *Bibliography of Canadian Law* (1977) and his *Supplement* (1982) and Carswell's *Index to Canadian Legal Literature* (including *Canadian Current Law*). Also surveyed were the *Index to Canadian Legal Periodical Literature*; the *Tables décennales* (1970-1979) of the *Revue générale de droit*, (1979) 10 *R.G.D.* (special number 3); the *Index analytique et tables diverses* (1966-1976) of the *Revue juridique Thémis*, (1978) 13 *R.J.T.* 713-1013; the *Tables générales de la Revue du Barreau* (1941-1955); (1955-1978); the *Consolidated Index to the Canadian Bar Review* (1923-1972); the *Index et tables* (1959-1966) of *Les Cahiers de droit* (1966); the *Index Cumulatif* of the *Revue de droit* (1970-1980), (1980) 10 *R.D.U.S.* 666-696; the *Annuaire de jurisprudence du Québec*; the *Tables des matières* de la *Revue du Notariat* (1898-1948); (1948-1958); (1958-1968); (1968-1978); The *Répertoire des thèses de doctorat et de maîtrise soutenues dans les facultés de droit des universités du Québec et de l'Université d'Ottawa, Section de droit civil*.

The compilation of the most recent books is based on *Canadiana* (National Library of Canada) and the *Bibliographie du Québec* (Bibliothèque Nationale du Québec).
